April 7, 2008

The Board of Mayor and Aldermen met in regular session on Monday, April 7, 2008 in the municipal courtroom at 7 p.m.

Mayor John Holden presided with all Aldermen present.

The meeting opened with the “Pledge of Allegiance to the Flag” followed by prayer by Alderman Dennis Moody.

The minutes of the March 17, 2008 and April 3, 2008 meetings were approved on a motion by Aldermen Williams and McCright.

Police Department Activity Report

Chief Terry Ledbetter outlined the police activity report for the period January through March of 2008. He reported that the bike patrol is having a dramatic effect on drugs, money, and vehicles. Petty theft is a city-wide problem that is being addressed.

Beer Ordinance Procedure

Associate City Attorney Christine Coronado presented an update procedure for submittal and review of beer permits. The current application is 20 years old. Improvements include more detail on the application, a packet to guide an applicant step by step, and a streamlined process.

The new beer permit application, checklist, and process was approved on a motion by Aldermen Kirk and Williams.

Liquor License Transfer: The Liquor Store – Roanne W. Burton

City Recorder Gleyn Twilla explained that Ms. Burton had submitted an application to the Tennessee Alcoholic Beverage Commission to be licensed to operate The Liquor Store at 1697 Highway 51 Bypass North. The State requires a “Certificate of Compliance – Retail Package Store” to be signed by the Mayor. He stated that Ms. Burton meets all four requirements certified on the compliance form.

On a motion by Aldermen Kirk and McCright the Board approved signing the “Certificate of Compliance”.

#### Finance Committee Report

Chairman Lewis Norman reported on the meeting of March 25, 2008. Mr. Bill Escue had presented a request for the City to provide 45% of the development costs for a 54 lot affordable housing subdivision. Mayor Holden reported that the City had fulfilled its commitment to the Burks Farms development by providing a lot and \$31,214.97 toward the cost of a sewer lift station.

#### Public Safety Committee Report

Chairman Bob Kirk reported on the meeting of March 28, 2008. Police Chief Ledbetter had requested purchase of a crew cab truck for the bike squad and a car for the homeland security taskforce officer. The purchase was recommended to the full Board.

Fire Chief Veal distributed copies of the new disaster preparedness resource manual. He was instructed to come back to the Committee with his recommendation regarding departmental certification.

Mayor John Holden announced the liquor license transfer at The Liquor Store on the bypass and the new beer permit application and process.

Alderman Walker inquired about vehicles for "First Responders". He asked if the ambulance service should be run by the City.

Alderman Norman inquired about changes to the truck route and driver safety school to be handled by the City.

#### DSCC Name Change

Alderman Norman reported on the action of the Board of Regents in recommending the DSCC name change. The Board asked the Mayor to send a letter to the Board of Regents stressing the City Board's continued opposition to the proposed name change.

#### Reports

Aldermen Kirk and Williams cheered on the University of Memphis Tigers in the basketball championship game.

Alderman Dudley expressed concern with CableOne's response to the Mayor's letter about quality of service.

Alderman Walker urged department heads to conserve fuel.

Alderman Moody expressed concern about substandard rental property.

The meeting adjourned at 7:25 p.m.
