Board of Mayor and Aldermen Meeting April 1, 2019 Dyersburg Municipal Court Room

(1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Monday, April 1, 2019 in the Dyersburg Municipal Court Room at 7:00 p.m. Mayor John Holden presided over the meeting. The meeting opened with prayer by Alderwoman Mary Claire Hopper. Mayor Holden noted all Aldermen were present.

(2) Approval of Minutes:

Mayor Holden called for a motion to approve the minutes from the March 18, 2019 meeting. Alderman Wille Cole made a motion to approve the minutes. Alderman James Baltimore seconded the motion. The minutes were approved.

- (3) Unfinished Business: None presented.
- (4) New Business

a. Approval of proposed TIF Project – David Hayes and John Lannom

David Hayes of the Industrial Development Board [IDB] presented information and plans regarding the construction of a retail sales complex. The project is currently called the "Commons". The developer Mr. Brandon Buchanan, of BRG Development Partners requested the city and the county assist the project development in applying for TIF (Tax Increment Financing). If approved by the Aldermen Board, the city will experience significant advantages in progressive retail development attraction, and major long term increases in real property tax collection. The specific listing of tax and other advantages were recorded in the Minutes of the Finance Committee meeting March 14, 2019, and presented at the Board of Mayor and Aldermen meeting March 18, 2019.

It had been established at the Finance Committee meeting March 14, 2019, that the timeframe for city and county approval was of high importance. The Local Government Committee for the County was presented the information on Wednesday, March 13, 2019, and approved the project for presentation to the full Dyer County Legislative Body. A motion had been made and approved by the Finance Committee and City Board to proceed forward with the TIF program, provided after the IDB meeting, (which met on April 1, 2019 at 2:00 p.m.), the IDB representatives should attend the Board of Mayor and Aldermen meeting on April 1, 2019 at 7 p.m. for any concerns or final discussion before final approval was made by the Board.

Mr. Hayes and Mr. Lannom presented further information as necessary for discussion before the Board. At the end of positive discussion, Alderman Ricky Hammond motioned for Board approval of the TIF project. Alderman James Baltimore seconded the motion and the Board

formally approved the TIF project. As a retired employee of First Citizens National Bank, Alderman Burks offered to abstain from voting, if the Board considered his vote (**for**) the motion to be in conflict of interest. No members of the board felt this to be a conflict, therefore the motion was unanimously approved for support of the "Economic Impact Plan and Tax Increment Financing for The Commons Retail Development Project".

The resolution is as follows:

RESOLUTION 04012019

Approval of Economic Impact Plan and Tax Increment Financing for The Commons Retail Development Project

WHEREAS, The Industrial Development Board of Dyer County, Tennessee (the "IDB"), has been approached by BRG Development Partners ("Developer") seeking financing in order to develop a certain tract of real property located on Hwy 51 Bypass W in Dyersburg, Dyer County, Tennessee, consisting of approximately 22 acres behind Dairy Queen and Triple T Tire, with road frontage between these two businesses, into a high profile retail project that includes new fast casual restaurants, furniture and home goods retailers, clothing, shoe and jewelry retailers in a shopping center of 118,000 square feet, with an additional 10,000 square feet shopping center to be built on one outparcel, and 3.5 acres for future development (the "Project");

WHEREAS, the IDB has prepared an economic impact plan (the "Economic Impact Plan") regarding the improvement of an area comprising the property on which the Project is located (the "Plan Area");

WHEREAS, the improvement of the Plan Area would include construction of the public infrastructure for the Project and a large parking lot surrounding the Project, constituting a "project" as defined in T.C.A. § 7-53-312;

WHEREAS, the Economic Impact Plan would permit the IDB to finance the Project through the issuance of the IDB's bonds, notes and other obligations in the total amount not to exceed \$3,000,000.00 pursuant to T.C.A. § 7-53-312;

WHEREAS, the incremental increase in real and personal property tax revenues to Dyer County, Tennessee ("County") and the City of Dyersburg, Tennessee ("City") from the Plan Area following completion of the Project, in the manner described in the Economic Impact Plan, will be allocated by the City and the County to the IDB, and paid to the IDB, to be used exclusively to pay the debt service incurred by the IDB to finance the Project and the IDB's allowable expenses, until such debt service is retired ("Tax Increment Financing");

WHEREAS, the IDB, held a public hearing pursuant to T.C.A. § 7-53-312, on the Economic Impact Plan, after which it has approved the Economic Impact Plan attached hereto as **Exhibit A**, and the IDB has submitted it to the County Commission of Dyer County, Tennessee, and the Board of Mayor and Aldermen of the City of Dyersburg, Tennessee for their separate approval in accordance with T.C.A. § 7-53-312; and

WHEREAS, the Tax Increment Financing shall not represent or constitute a debt or pledge of the faith and credit or the taxing power of the City of Dyersburg, Tennessee.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Mayor and Aldermen of the City of Dyersburg, Tennessee that the Economic Impact Plan, attached hereto as **Exhibit A**, being in the interest of the citizens of the City of Dyersburg, Tennessee, is hereby approved, and the officers of the City are authorized to take all appropriate actions to carry out the terms of the Economic Impact Plan.

This Resolution is adopted on the 1st of April, 2019.

He especially remarked on his letter to the Director of the Dyersburg City Schools, as requested by the Aldermen, concerning the timeliness of the submission of the City Schools audit report. He noted that as soon as he receives a reply, he will forward the response to the Board.

With no further business, the committee adjourned at 10:15 a.m.
